INTERNATIONAL COMPETITIVE BIDDING (ICB)

The Chairman, Standing High-Level Procurement Committee (SHLPC) on behalf of Litro Gas Lanka Limited invites sealed bids from eligible and qualified bidders for the Supply of Empty LPG Cylinders without Valves for the period of 2025 - 2026.

To be eligible for contract award, the successful bidder shall not have been blacklisted and not have any conflicts of interest in the business of Litro Gas Lanka Limited or its associated companies. (further details are mentioned in the bid document).

The bidder shall have a valid permit from the Sri Lanka Standard Institute (SLSI) and a copy of the certificate should be produced when collecting the bid documents.

All bids shall be accompanied by a Bid Security in the form of a Bank Guarantee from any licensed commercial bank registered in Sri Lanka issued in favor of Litro Gas Lanka Ltd amount of the bid security is as follows and shall be valid up to 26th July 2025.
